Austrian online betting brand

bwin Interactive Entertainment AG, formerly known as Betandwin, is an Austrian online betting brand acquired by Entain PLC. The group operated under international and regional licences in countries like Gibraltar, the Amerindian reserve of Kahnawake (Canada), and Belize; and Germany, Italy, Mexico, Croatia, Austria, France,[2] and the United Kingdom in Europe. Bwin offered sports betting, poker, casino games, and soft and skill games, with most revenue coming from poker and sports betting. bwin had over 20 million registered customers in more than 25 core markets. Competence centres were located in Vienna, Stockholm, and Gibraltar.[3]

The company provided services for its subsidiaries such as marketing, finance, and administration, corporate communications, controlling, and IT services. All operational activities were managed by licensed subsidiaries. It was listed on the Vienna Stock Exchange from March 2000 until the company's merger with PartyGaming plc in March 2011, forming Bwin.Party Digital Entertainment. That company was purchased by GVC Holdings in February 2024; GVC continues to use bwin as a brand.

History [ edit ]

Beginning with 12 employees in its founding in 1997, bwin was formerly known as "betandwin" until 2006. The company launched its first online gambling site in 1998, focusing on the growing sports betting market. One of the most important developments in the company's history was the launch of its live betting product, developed in-house, allowing players to place bets on sporting events while the actual event was taking place. The firm's initial public offering at the Austrian Stock Exchange took place in March 2000.

Betandwin acquired Simon Bold (Gibraltar) in June 2001 and changed its name to bwin International Ltd. This relocation to Gibraltar was done to keep up with the company's main competitors, who had already moved to the British Overseas Territory.

By December 2001, betandwin was ready to step into the online casino gaming market and did so by launching its first casino platform. Two years later, in July 2003, betandwin introduced and launched a soft games platform known as "Balls of Fire".

In November 2004, betandwin launched multiplayer poker. In June 2005, the group acquired betoto, a company which offers a fixed-odds betting service to punters around the globe, in an effort to expand its presence in the Greek market.

In December 2005, betandwin acquired Ogame e-Solutions AB, a move consistent with the

group's strategy to expand into the poker market. After the takeover, Ongame e-Solutions changed its name to bwin Games. In 2005, betandwin acquired global media rights outside of Germany to the Germany Football League.

In August 2006, betandwin launched the new bwin brand. This was done after it was found that the betandwin brand, which was described as "descriptive, high-grade and functional", was not suited anymore for the wide assortment of entertainment offerings covered by the company, including sports betting, poker, soft games, and casino games.

In 2007, bwin began to offer live streaming of major sports events.

In September 2009, bwin announced the acquisition of Italian poker operator Gioco Digitale, marking the company's entry into the Italian online gambling market.[4][5]

Bwin is often confused with BetWinner, but they are different bookmakers, with individual features and advantages.[6]

PartyGaming merger [ edit ]

On April 1, 2011, bwin and British gaming firm PartyGaming announced their merger. The new company bwin.party became the world's largest publicly traded online gaming firm, 48.4% of which was owned by existing PartyGaming shareholders and 51.6% by bwin shareholders. The merged company was listed on the London Stock Exchange, with joint CEO's Norbert Teufelberger and Jim Ryan.[7] After a takeover of bwin.party by British GVC Group, the brand bwin continues to exist as customer brand in its portfolio.

Products [ edit ]

The company's subsidiaries and affiliated companies offer sports betting, poker, casino games, and soft games, as well as audio and video streams on sporting events, such as the German Bundesliga. These are all provided via the Internet, and many are also available via other digital distribution channels, such as mobile phone.

Sports Betting [ edit ]

Sports bets are the core business at bwin. Today, the sports betting line-up includes more than 90 different sports; the core area of customer interest is soccer. Other sports include all popular ball-related sports, US sports, as well as all major winter sports and motorsports ranging from Formula 1 to MotoGP. "Exotic" sports such as Roller Hockey, Futsal, and Darts are also included in the daily line-up. Customers can also find odds on a range of events outside the area of sports. These include bets on politics and entertainment, such as the Oscars, Talent Shows, the Eurovision Song Contest, and "Miss" events.[8]

Poker [ edit ]

The following types of games are offered at bwin Poker: Texas Hold'em, Omaha, Omaha Hi/Lo, Seven Card Stud, Seven Card Stud Hi/Lo, and Five-card draw. In terms of stakes, users can choose between Fixed Limit, Pot Limit, or No Limit tables. A "play money" version of the games is also available for users to try for free. bwin offers poker tournaments, including Sit & Go, scheduled, and cash games (ring games). Sit & Go tournaments begin as soon as the table is completely occupied. Scheduled tournaments begin at a specified time and allow for a higher numbers of participants and the highest prize pools. In cash games the players can join and leave at-will. bwin Poker can be played using the Mac OS X Poker Client, the Windows Poker Client, the Java Poker Client, or the Mobile Poker Client. The Mac and Windows versions offer an extensive selection of features such as statistics and a mini-table function. The Java client is platform-agnostic and browser-based. The mobile client allows customers to play cash games on their mobile phones.[9]

Casino Games [ edit ]

bwin offers more than 1000+ games, ranging from classics such as roulette or blackjack to slot machines and casino tournaments. The casino has a longstanding tradition at bwin, but in 2001, it was introduced as a second product, in addition to sports betting.[10]

Soft Games [ edit ]

bwin offers more than 60 games divided into the categories of Fortune Games, Skill Games, Mini Games and "ParaDice", as well as Backgammon. This is the product group with the biggest potential for innovation and expansion in the market.[11]

[bwin Games AB \[ edit \]](#)

bwin Games AB – founded in 1999 and formerly known as Ongame e-solutions AB – became part of the bwin Group following its acquisition, in March 2006, by bwin Interactive Entertainment AG. Within the bwin Group, bwin Games AB acts as the competence centre for poker and casino games, developing products via digital distribution channels for bwin proprietarily owned brands, such as PokerRoom, HoldemPoker, eCardroom, PokerGaming, Europoker, and the Ongame Network partners.

PokerRoom was an online poker cardroom founded in 1999. Licensed by the Kahnawake Gaming Commission, PokerRoom offered both play and real money formats. Tournaments and ring games were available in both web-browser and download client platforms, with support for both Macintosh and Linux. PokerRoom was one of the first online poker sites to provide multi-language support, and catered to Danish, German, Spanish, French, Italian, Russian, and Swedish speakers. These languages were accessed via "regional sites", many of them showing local sponsorships for the selected region.

PokerRoom also maintains a play money only site, PokerRoom.tv, that is advertised in Canada on the boards of National Hockey League rinks, as well as on U.S. television networks like ABC.

PokerRoom has won industry awards, such as "Poker Site of the Year" from the UK Gambling Awards in 2006 and "Top Poker Software" from the Online Gambling Magazine Awards in 2005.

[Shutdown \[ edit \]](#)

After 10 years of operation, bwin announced the closure of PokerRoom on April 14, 2009. Players with money still left in their accounts were encouraged to transfer their balance and play at bwin.[12] However, PokerRoom players with large "play money" accounts had to abandon those accounts when transferring to bwin.

[Legal Status \[ edit \]](#)

As the global legal framework for Internet gambling is a complicated mix of laws and regulations, bwin's situation varies depending on the country concerned. For several years now, the United Kingdom and Italy have been examples of countries that have regulated their online gaming markets to the advantage of all stakeholders. Just recently, Italy extended its online licenses to include poker tournaments, and countries like France, Spain, and Denmark announced their intention to permit private operators access to their markets under stringent conditions and controls. Other countries, on the other hand, are still pursuing a policy of maintaining a state monopoly of internet gaming, or even a complete ban.

On 15 September 2006, Norbert Teufelberger and Manfred Bodner were arrested[13] at a press conference in La Turbie, France, due to offenses against the French gambling laws. After an investigation the judge released them on the evening of September 18, 2006.

Due to the enactment of the Safe Port Act, bwin stopped taking bets from United States-based players in October 2006.[14] The offerings became available again upon regulation of the markets. In the States where regulation is in place, the same product line offered through bwin is available through BetMGM, the joint venture of bwin's parent company Entain PLC's with MGM Resorts International.

On 6 March 2007, the European Court of Justice struck down Italian national gambling restrictions in the Placanica case.[15]

The EFTA Court held hearings in January 2007 to decide on the admissibility of a state monopoly for betting and gaming according to European Law. The decision of the EFTA Court will be made on 14 March 2007.[citation needed]

In February 2024, bwin ended its operations in Russia. An agreement was made with Parimatch enabling customers to transfer platforms along with their funds.[16]

bwin sponsored football giant Real Madrid from 2007 to 2013 and they were also a premium partner of FC Bayern Munich. In October 2010, bwin announced a sponsorship for the upcoming three football seasons in which they would be the title sponsor of the Portuguese League Cup (renamed the "bwin Cup").[17] In July 2010, bwin signed a two-year sponsorship deal with Italy's

second tier, Serie B. Additionally, bwin cooperates with the International Basketball Association (FIBA) and has been sponsoring the European and World Basketball Championships since 2006. In the area of motorsport, the company is one of the main sponsors of the MotoGP series. In 2010, bwin became the title sponsor of the races in Jerez and Estoril and official partner of the GP in Brno, Misano, Mugello. In the past, many other popular events across international and local sports were supported by bwin. bwin also lent its name to the Primeira Liga (bwinLIGA), sponsored Italian football club Milan from 2006 to 2010, and has also been a partner to popular football clubs, such as Real Madrid, Juventus and Werder Bremen.[18]

In addition, bwin organised numerous online and offline poker events. One of the biggest regular online poker tournaments was the ChampionChip. Special poker tournaments, like the Weekly Country Showdown or the bwin Dailies, offered a huge range of tournaments adjusted to specific country regulations and buy-in levels. Periodically new types and variations of Sit & Go tournaments were launched. Through several online qualifying events, a bwin user could qualify for offline events like the World Series of Poker (WSOP), the Aussie Millions, and events on the World Poker Tour. For "poker newbies", bwin offered a special route - the Rookie Challenge, where a new poker player had the chance to climb up several stages for free to earn real money tickets.

In 2008, bwin provided the luxury villa on bwin PokerIsland[19] as filming location for the music video of Lady Gaga's hit Poker Face. The video featured bwin branded poker equipment through a product placement campaign.[20]

The company faced some opposition in Europe over its sponsorship of sports, especially football. In 2006, Bremen banned its top football team, Sportverein Werder Bremen, from carrying the bwin logo on its shirts.[21] In November 2009, the city acted further by moving against sport stores which sold shirts from other teams, such as Milan and Real Madrid.[citation needed]

In 2024, bwin signed a three-year partnership with Italian football club Inter Milan becoming its first official betting partner.[22]

In 2024, bwin became Valencia CF's main global sponsor. The three-year agreement was made official in July 2024.[23] As of 2024 the agreement is in jeopardy with the Spanish government informing all La Liga clubs that betting sponsors will be banned from the start of the 2024-22 season.[24]

In 2024, bwin announced a three-year partnership with the Belgian Pro League becoming the official sports betting partner of Belgium's top tier football division.[25] The deal will also cover the Belgian First Division B and Belgian Super Cup. bwin is able to broadcast live coverage of football matches to customers using both online and mobile platforms as part of the agreement.

In April 2024, bwin signed a five-year partnership with Liga Portugal. As part of the deal, the Primeira Liga, Portugal's top football division, will be called Liga Portugal Bwin from July 2024 onward.[26]

In August 2024, bwin signed extended deals with German Bundesliga football clubs Borussia Dortmund, Union Berlin, and FC Köln, as well as 2. Bundesliga clubs FC St. Pauli and Dynamo Dresden.[27] As part of the deal, bwin will serve as the exclusive sports betting provider for each team. Each of the agreements will run from the 2024-22 season until the end of the 2024-24 season.

In September 2024, bwin signed a partnership with UEFA to become an Official Partner of the UEFA Europa League and the UEFA Europa Conference League for the 2024–24 seasons.[28] Responsible Gaming [ edit ]

A dedicated Corporate Social Responsibility department of the company was in charge of social responsibility. Protection of minors, protection against manipulation of bets, and the prevention of gaming addiction were key aspects of the bwin CSR philosophy. bwin supported research in this field in a joint project with Harvard Medical School. bwin is a co-founder of the EGBA (European Gaming and Betting Association), where it lobbied for fair competition within a regulated online gaming market. As founder and member of the ESSA (European Sports Security Association), bwin campaigned against manipulation and fraud in the fields of sports and betting.[29]

Awards [ edit ]

At the annual EGR Awards organised by eGaming Review magazine, bwin won the "Operator of the Year 2009" award.[30]

## **betfair bonus 5 reais :pixbet promoção**

Algumas das corporações mais lucrativas do mundo – e as empresas que são poluentes - investiram betfair bonus 5 reais projetos de compensação com carbono, os quais têm falhas fundamentais (e provavelmente lixo), sugerindo alegações da indústria sobre reduções dos gases causadores o efeito estufa foram muito exageradamente infladas.

Delta, Gucci Volkswagen e ExxonMobil estão entre as grandes corporações que compraram milhões de créditos carbono betfair bonus 5 reais projetos amigos do clima "provavelmente lixo" ou sem valor quando se trata da compensação das emissões dos gases com efeito estufa. De acordo como um sistema classificado desenvolvido pela Corporate Accountability (Responsabilidade Corporativa), uma organização não lucrativa transnacional para a proteção corporativa;

Algumas dessas empresas não usam mais compensações de CO2 betfair bonus 5 reais meio a evidências crescentes que o comércio do carbono, por exemplo e devido à falta das emissões declaradas – podem até causar danos ambientais ou sociais.

No entanto, a indústria de comércio voluntário multibilionária ainda é defendida por muitas corporações incluindo grandes empresas petrolíferas e gaseificada gás como base da ação climática – uma maneira para reivindicar reduzir betfair bonus 5 reais pegada do efeito estufa enquanto continua confiando betfair bonus 5 reais combustíveis fósseis.

No entanto, para 33 dos 50 principais compradores corporativos do top 5 de empresas compradoras mais que um terço da carteira total das compensações é "provavelmente lixo" - sugerindo pelo menos algumas reivindicações sobre neutralidade carbônica e reduções nas emissões foram exageradas segundo a análise. As falhas fundamentais levando à classificação como provavelmente sucata incluem se os cortes betfair bonus 5 reais emissão teriam acontecido mesmo assim (como muitas vezes acontece com grandes hidrelétrica), ou caso as mesmas tenham sido deslocadas apenas por outro lugar – uma questão comum nos projetos florestais offset).

"Essas descobertas aumentam a evidência crescente que descascará as fachada do mercado voluntário e revelarão como isso distrai perigosamente da ação real, duradoura das maiores corporações mundiais", disse Rachel Rose Jackson.

A indústria de combustíveis fósseis é, sem dúvida o maior investidor nos esquemas mais populares do mundo para compensar 50 CO2. Pelo menos 43% dos 81 milhões créditos betfair bonus 5 reais emissões compradas pelas grandes empresas petrolíferas e gaseífera são destinados a projetos que tenham pelo Menos uma falha fundamental (e sejam "provavelmente

lixo") segundo as análises realizadas pela empresa ndia

A indústria de transportes, que responde por cerca do quinto das emissões globais para aquecimento global dos planetas também dependeu fortemente betfair bonus 5 reais projetos compensadores com carbono. Pouco mais 42% da totalidade (55 milhões) créditos comprados pelas companhias aéreas e 38% adquiridos pelos fabricantes automóveis (21 metros), provavelmente não valem a pena reduzir as suas taxas no topo 50 projectos análise encontrada A nova análise, compartilhada com o Guardian baseia-se betfair bonus 5 reais uma investigação conjunta no ano passado sobre os 50 principais projetos de compensação CO2 – aqueles que venderam mais créditos carbono do mercado global. A grande maioria dos projectos compensados foram classificados como provavelmente ou potencialmente lixo devido a um erro fundamental e prejudica seu corte prometido nas emissões segundo critérios aplicados às análises

6. Os compradores corporativos foram classificados com base na quantidade de créditos comprados dos 50 principais projetos e qual proporção era provavelmente lixo. As empresas nomeadas são nomes conhecidos; compraram milhões betfair bonus 5 reais crédito CO2, mais do que um terço da carteira offset é provável sucata

Os 50 principais projetos incluem esquemas florestais, hidrelétricas e parques solares ou eólica. Eles representam quase um terço de todo o mercado global voluntário do carbono (VCM), sugerindo que créditos lixo sobrevalorizados betfair bonus 5 reais carvão podem ser a norma para reduzir as emissões excessivamente benefícios?!

A indústria de VCM trabalha por créditos carbono sendo negociáveis "permissões" ou certificados que permitem ao comprador compensar 1 tonelada do dióxido carbonizado, o equivalente betfair bonus 5 reais gases com efeito estufa investindo nos projetos ambientais no mundo todo e afirmando reduzir as emissões.

Especialistas betfair bonus 5 reais clima dizem que o mercado de comércio do carbono não conseguiu produzir os benefícios planetários prometido, atrasou a transição para longe da exploração petrolífera e gás natural (petróleo), além disso causou danos às florestas nos países onde se encontram mais projetos.

Na terça-feira, o governo Biden publicou novas diretrizes sobre a participação responsável betfair bonus 5 reais VCMs que dizem conduzirão uma ação climática credível e ambiciosa. Mas os críticos argumentam de forma fundamentalmente falha as compensações ”.

“No geral, as compensações de carbono não são credíveis nem escaláveis para a urgência e escala do problema”, disse Richard Heede.

“Este relatório documenta a prevalência de compensações ‘inúteis’ ou provavelmente lixo” no mercado global voluntário do carbono, e mina o raciocínio corporativo para reivindicar reduções das emissões com base betfair bonus 5 reais tais créditos”, acrescentou Heede.

A nova análise sector-por setor encontrou:

Empresas de combustíveis fósseis e companhias aéreas;

As maiores empresas de petróleo e gás estão entre os principais compradores corporativos dos prováveis deslocamentos do lixo. Quase metade (49%) das 3,7 milhões créditos carbono comprados pela ExxonMobil são para dois projetos classificados como provavelmente junk ou inútil, documentos internos da empresa mostram que cientistas na exxon - um daqueles piores emissores mundiais betfair bonus 5 reais gases com efeito estufa- estavam prevendo precisamente o impacto desses combustíveis fósseis no clima nos anos 1970

Um porta-voz da ExxonMobile disse: "Os deslocamentos de carbono são uma maneira viável para [reduzir as emissões e atingir o zero líquido], razão pela qual continuamos a avaliar. Estamos trabalhando betfair bonus 5 reais verificar os créditos citado nesta análise."

Com exceção das empresas de combustíveis fósseis, a Delta comprou mais créditos do que

qualquer outra corporação. Pouco menos 35% dos 41 milhões créditos carbono comprados pela empresa eram provenientes de 11 projetos offset provavelmente inúteis ou lixo eletrônico segundo Corporate Accountability (Responsabilidade Corporativa).

Na Califórnia, uma ação de classe civil alegou que a Delta se apresentou como neutra betfair bonus 5 reais carbono à medida na dependência da empresa no mercado comercial do carvão tornando suas representações favoráveis ao clima falsas e enganosas. O juiz reduziu o escopo das ações judiciais mês passado depois dela rejeitar as alegações para apresentar um pedido por betfair bonus 5 reais renúncia continuando assim com os casos apresentados pelo tribunal federal dos EUA (ver nota).

Um porta-voz disse que a empresa está investindo betfair bonus 5 reais combustível de aviação sustentável, aeronaves mais eficientes e reduzindo o uso do consumo por meio da eficiência operacional para alcançar "zero líquido" até 2050.

Enquanto isso, quase 72% dos créditos de carbono 11m já comprados pela easyJet eram para projetos classificados como lixo provável. Em 2024 a companhia aérea anunciou planos da transição longe do compensamento betfair bonus 5 reais favor das emissões "roteiro até zero líquido" por 2050 através mais eficiente combustível aeronaves e eficiências peracionais bem com o consumo sustentável aviação combustíveis capturando carvão - tecnologias que os cientistas alertaram poderia agravar as crises climáticas...

Um porta-voz da easyJet disse: "No curto período betfair bonus 5 reais que compensamos as emissões dos clientes, tivemos processos robustos de due diligence implementado com todos os projetos recomendados por parceiros especializados e necessários para atender aos mais altos padrões disponíveis".

Uma investigação conjunta de 2024 pelo Guardian revelou que as principais companhias aéreas, incluindo Delta e easyJet estavam usando créditos "fantasmas" não confiáveis para reivindicar seus voos eram neutros betfair bonus 5 reais carbono.

Fabricantes de carros, gigantes do entretenimento e bens luxuosos.

Quase metade (46%) dos 11 milhões de créditos CO2 comprados pela Volkswagen nos 50 principais projetos eram provavelmente lixo, segundo a análise. A montadora alemã anunciou recentemente uma joint venture para desenvolver seus próprios projetos betfair bonus 5 reais crédito ao carbono e disse que cada vez mais dependem das inspeções no local due diligence (duetos da auditoria) processos - verificar os mesmos – o objetivo é reduzir suas emissões 90% comparado com 2024 convertendo seu suprimento energético por meio do aumento na eficiência energética entre outras medidas;

No mundo do entretenimento, quase 62% dos 5 milhões de créditos carbono aposentados pela Disney são provenientes da criação e desenvolvimento das duas franquias que foram classificadas como lixo ou inútil.

A análise também descobriu que 75% dos créditos de carbono 4,4 milhões comprados pela Gucci foram para projetos classificados como lixo provável. O ano passado a empresa caiu betfair bonus 5 reais reivindicação neutra betfair bonus 5 reais relação ao Carbono no meio da crescente evidência do fato das florestas tropicais serem provavelmente junk e potencialmente prejudiciais; está finalizando novos compromissos climáticos com maior foco na redução absoluta nas emissões através dessa cadeia produtiva ndice

A indústria de alimentos e bebidas é um grande poluidor do clima –e investidor nos mercados da emissão, com 37% dos créditos betfair bonus 5 reais toda a indústria comprados por projetos classificados como lixo provável.

Indústria alimentar e de bebidas

A análise constatou que quase 36% dos 2,2 milhões de créditos betfair bonus 5 reais carbono comprados pela Nestlé, a maior empresa mundial do setor alimentar e bebidas foram provenientes de cinco projetos compensados classificados como lixo provável. Segundo o estudo realizado na semana passada por meio das empresas norte-americanas pararam as compras desses programas no ano 2024/2024 "Atingir zero emissões líquidas não envolve usar

compensação: nos concentramos nas reduções ou remoções dessas taxas dentro nossa cadeia produtiva".

Enquanto algumas corporações sinalizaram uma mudança para longe da compensação de carbono, o VCM ainda é avaliado entre BR R\$ 2 e 3 bilhões - apesar dos avisos que a indústria seja um falso solução atrasando transição do mundo fora das indústrias petrolíferas.

"Esta pesquisa mais uma vez mostra que grandes poluidores corporativos reivindicando credenciais climáticas são os principais compradores de créditos lixo. Mas acumular crédito carbono não faz você um líder climático ". Cortar combustíveis fósseis sim, mas nós podemos compensar o nosso caminho para a segurança do clima futuro", disse Erika Lennon betfair bonus 5 reais comunicado à imprensa no Centro Internacional Direito Ambiental (Ciel).

"Apesar de toda a conversa sobre créditos carbono acelerando ação climática, eles estão realmente limpam o clima da destruição."
