Tornou-se a outra "torre de inclinação" da Itália. E agora, depois do crescente receio que o Torre Garisenda championsbet Bolonha possa estar à beira ao colapso e um plano foi elaborado para salvá-lo usando os mesmos equipamentos usados na torre Pisa!

A torre Garisenda de 48 metros (158 pés) foi construída no século XII, durante um período boom da história do norte cidade's mas dois séculos depois já tinha começado a inclinar. Hoje championsbet dia ele se apoia num ângulo dos quatro graus apenas pouco mais que o atual inclinação 3.9 grau Torre Pisa "S

No ano passado, as ruas ao redor da Garisenda foram temporariamente fechadas enquanto os cientistas monitoravam a estrutura championsbet busca de evidências do movimento e rachaduras.

O prefeito de Bolonha, Matteo Leporé s anunciou na quarta-feira que pilares e cabos usados anteriormente para salvar a torre championsbet Pisa seriam implantado com andaimes adaptados ao aço.

"Isso tornará possível proteger a torre", disse Lepore championsbet uma coletiva de imprensa.

Ele afirmou que poderia permitir à Torre Asinelli, estrutura mais alta ao lado da Garisenda e reabrir para o público ”.

“Em 2025 e 2026 haverá mais trabalhos de consolidação, que ainda precisam ser planejados”, acrescentou Lepori.

O prefeito disse que deve levar "cerca de seis meses" para adaptar o equipamento usado na Torre da Pisa a Garisenda, com toda operação garantida custando cerca 19 milhões (aproximadamente US\$ 20 bilhões).

Uma vez que as duas estruturas de pilares de aço usadas no Pisa sejam erguidas e adaptadas a Garisenda, o trabalho de consolidação começará na alvenaria do edifício. incluindo injeções com uma mistura à base de gesso compatível ao usado nas construções originais dos edifícios (de acordo como um comunicado).

Em seguida, os cabos que conectam as torres a andaimes ligados à torre seriam apertados? um procedimento para diminuir o estresse na base da Torre.

Embora menos conhecida do que a contraparte de Pisa, Torre Garisenda tem sido uma atração turística há muito tempo na Bolonha. Seu ângulo incomum lhe valeu menção no poema de Dante Alighieri século 14 "Divina Comédia". Ao lado dele o mais alto torre Asinelli também é um turista atração com inclinação modesto 1,3 graus

A Torre de Pisa, a peça central do Patrimônio Mundial da UNESCO na Itália atingiu uma inclinação no início dos anos 90. O medo por estabilidade levou ao esforço internacional para impedi-la que caísse sobre o solo com um trabalho durando oito anos desde 1993;

Hoje a torre do sino é um monumento estável, principalmente graças aos pilares de aço que esperamos dar à Torre Garisenda uma segunda vida.
