Estados Unidos: activista texano demanda investigación sobre aborto legal en otro estado

Desde que la Corte Suprema de los EE.UU. derogó la sentencia Roe v Wade hace dos años, los activistas contra el aborto han debatido si y cómo restringir la capacidad de los estadounidenses para viajar a otros estados para someterse a abortos legales. Ahora, un hombre de Texas ha solicitado a un tribunal que autorice una investigación sobre el aborto que, según afirma, recibió su expareja en un estado donde el procedimiento sigue siendo legal.

El activista texano Collin Davis quiere investigar el aborto legal de su expareja en Colorado

Collin Davis afirmó en documentos judiciales que, cuando supo que su expareja planeaba interrumpir su embarazo en febrero de 2024, contrató a un abogado que "perseguiría reclamaciones por muerte wrongful-death contra cualquier persona involucrada en el asesinato de su hijo por nacer". Según los documentos, la mujer se sometió a un aborto en Colorado, un estado que se ha convertido en un refugio para el aborto a medida que entran en vigencia leyes que prohíben el procedimiento en gran parte del medio oeste y el sur de EE. UU.

Intenta utilizar una ley texana para averiguar quién "ayudó o abetó" el aborto

La petición de Davis, presentada en marzo y reportada por primera vez por el Washington Post la semana pasada, pretende utilizar una ley texana que permite a las personas solicitar deposiciones legales antes de presentar una demanda, con el fin de determinar quién puede haber "ayudado o abetado" el aborto de la mujer. Davis argumenta que, si la investigación descubre alguna irregularidad, puede demandar en virtud de la ley de homicidio culposo de Texas o de una ley estatal que permite a los particulares demandarse mutuamente por sospecha de "ayudar o abetar" un aborto después de seis semanas de embarazo.

Quiere demandar a "co-conspiradores y cómplices"

Aunque Davis no tiene la intención de demandar a la mujer que se sometió al supuesto aborto, está evaluando si demandar a "co-conspiradores y cómplices" - un rango aparentemente amplio de personas que podría incluir a "cualquier individuo ... involucrado en el asesinato del hijo por nacer de Sr. Davis".

Intentan restringir el derecho a viajar para los abortos

Es legal que las personas viajen a otros estados para someterse a abortos legales. Sin embargo, los activistas decididos a poner fin al aborto a nivel nacional han lanzado una serie de ofensivas legislativas y judiciales para socavar ese derecho, a menudo **dirigiéndose a grupos y**

individuos que pueden ayudar a los pacientes a viajar.

Idaho, Texas y Alabama han aprobado leyes restrictivas

Idaho ha promulgado una ley que prohíbe a las personas ayudar a los menores a salir del estado para someterse a abortos legales a menos que tengan el consentimiento paterno. Pequeñas localidades en Texas han promulgado una serie de Ordenanzas para restringir la capacidad de las personas para transportar a otras por carreteras locales para abortos fuera del estado. El Fiscal General de Alabama ha amenazado con procesar a los grupos que ayudan a las mujeres a salir del estado para abortar — una amenaza que un juez federal rechazó enfáticamente al principio de esta semana.

Aunque el caso de Davis aún no ha sido resuelto, ya ha generado preocupación y debate sobre los límites del derecho al aborto y la capacidad de los estados para restringir el movimiento interestatal. Mientras algunos afirman que los estados tienen derecho a imponer sus leyes dentro de sus fronteras, otros arguyen que restringir el derecho al viaje viola las libertades constitucionales.
